## ORDINANCE NO. 2008-3 of the Village of Bismarck Vermilion County, Illinois

## AN ORDINANCE ACCEPTING THE STREETS LAID OUT IN HIGH PLAINS ESTATES

WHEREAS, High Plains Estates is a subdivision laid out in Newell Township, Vermilion County, Illinois; and

WHEREAS, the plat of High Plains Estates was recorded in the Office of the Vermilion County, Illinois, Recorder, May 23, 1978, as Document Number 928996; and

WHEREAS, the plat of High Plains Estates includes streets named thereon as High Drive and Wilson Street which are designated as private; and

**WHEREAS**, the Certificate of Survey for High Plains Estates recorded in the Office of the Vermilion County, Illinois, Recorded May 23, 1978, in Book 945, at Pages 551-555, contains restrictions incorporated therein, including 4.M thereof, providing as follows, to wit:

"The streets in this Subdivision are private and will not be maintained by the Community of Bismarck or Newell Township until such time that said streets are excepted as Public Right-of-Way. Until such time it will be the responsibility of each lot owner to pay their proportionate share of any maintenance costs that may be required."

at page 3 thereof; and

WHEREAS, High Plains Estates is now situated within the confines of the Village of Bismarck, Vermilion County, Illinois; and

WHEREAS, the Village of Bismarck, Vermilion County, Illinois, now desires to accept the streets as platted in High Plains Estates;

NOW THEREFORE be it ordained by the President and Board of Trustees of the Village of Bismarck, Vermilion County, Illinois, that the streets laid out and platted in High Plains Estates be and the same are hereby accepted as public streets of the Village of Bismarck, Illinois;

That this Ordinance shall be published in pamphlet form.
