AN ORDINANCE PUBLISHING THE OFFICIAL
ZONING MAP FOR THE VILLAGE OF BISMARCK

WHEREAS, the corporate authorities of the Village of Bismarck, by ordinance adopted September 18, 2001, have heretofore exercised the powers conferred by Division 13 of the Illinois Municipal Code (65 ILCS 5/11-13-1 et seq.) to enact boundaries of districts and appropriate regulations for the zoning of lands lying within its incorporated boundaries and in unincorporated territory within one and one-half miles of its corporate limits; and

WHEREAS, pursuant to the aforementioned Division 13, the corporate authorities of the Village of Bismarck are directed to publish no later than March 31 of each year a map clearly showing the existing zoning uses, divisions, restrictions, regulations and classifications of such municipality for the preceding year, unless there are no changes therein; and

WHEREAS, the "official zoning map" of the Village has been updated to reflect changes made through September 23, 2010.

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Bismarck, Illinois:

That the official zoning/subdivision map dated September 23, 2010, a copy of which is attached hereto and incorporated by reference, be and the same is hereby published as the "official zoning map" of the Village of Bismarck.


