

**ORDINANCE # \_\_\_\_\_**

**AN ORDINANCE LEVYING REAL ESTATE TAX FOR CORPORATE PURPOSES**

WHEREAS, the corporate authorities of the Village of Bismarck are authorized by the statutes of the State of Illinois at 65 ILCS 5/8-3-1 to levy and collect real estate taxes for corporate purposes without public referendum at a rate not to exceed .25% upon the aggregate valuation of all property within the corporate limits of the Village of Bismarck; and,

WHEREAS, the corporate authorities of the Village of Bismarck have determined, after much discussion and reflection, that the welfare of the citizens of Bismarck will be better served by the Village's collection of such tax funds.

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Bismarck, Vermilion County, Illinois as follows:

Section 1: That the sum of \$12,000 is hereby levied upon all property subject to taxation with the Village of Bismarck as that property is assessed and equalized in order to meet and defray the necessary expenses and liabilities of the Village as required by statute for 2017.

Section 2: That the amount levied for each object and purpose shall be as follows:

General Village Fund

County Police Reimbursement	5,000
Public Works Payroll	<u>7,000</u>
	12,000

Section 3: That the total amount of \$12,000 ascertained above, be and is hereby levied and assessed on all property subject to taxation within the Village of Bismarck according to the value of said property as assessed and equalized for state and county purposes for the current year.

Section 4: That the Village Clerk shall make and file with the County Clerk of Vermilion County on or before the last Tuesday of December a duly certified copy of this ordinance.

Section 5: That this ordinance shall be in full force and effect after its adoption as provided by law.
