Minutes of Planning Commission Committee Meeting and Public Hearing,
September 20, 2022

- 1. At 6:30 p.m. the Planning Commission Committee held a public meeting regarding the property at 17085 East 2550 North Road in Danville, II 61834 for a rezoning request from Mr. Matt Creed from residential to commercial. The meeting had to be moved from the Village of Bismarck Office to the Bismarck Men's Club due to the large crowd that showed up for the meeting. The Planning Commission heard public comments from the community regarding the proposed change in zoning. The planning commission committee gave everyone in the audience a chance to speak, ask questions and respond to their concerns regarding the rezoning request. The majority of the audience was in support of Mr. Creed's request for rezoning. The planning commission chairperson Rick Kentner thanked everyone for attending the public hearing and stated that they would reconvene at the Village Office for an open meeting to discuss the residents' concerns and opinions raised during the public hearing and vote on a recommendation to give to the Village of Bismarck Board of Trustees at their next meeting scheduled for September 27<sup>th</sup>, 2022.
- 2. Discussion of Building Permit/Special Permit/Zoning/Re-Zoning Requests
  - a. Planning Commission Committee members discussed the community members concerns and opinions. They discussed that the vast majority of the residents that appeared for the public hearing were in favor of rezoning the property for Mr. Creed so that he can build a new building for his business. There were a couple of residents that voiced concerns.
- 3. Decision of Building Permit/Special Permit/Zoning/Re-Zoning Requests
  - **a.** Planning Commission Committee members voted to make a recommendation to the Village of Bismarck Board of Trustees at their next regular meeting being held on September 27<sup>th</sup>, 2022 at 6:30pm, to approve the rezoning request from residential to commercial for Mr. Matt Creed as requested based on the information reviewed, public hearing concerns and comments noted, and the overwhelming support given to Mr. Creed by the residents. With an unanimous vote, we, the planning commission committee recommend the approval of rezoning the property located at 17085 East 2550 North Road in Danville, II 61834, that resides in the mile and half "buffer zone" of the Village of Bismarck, from residential to commercial.
